Dear Parent,

It has come to our attention that there is a small minority of parents that are using the hubs for childcare when they are not in work.

Please can we remind you that you should only book your children into the hubs to cover your working hours; and if your children cannot be cared for by a spouse or other family member. These hubs have been provided for critical workers only to ensure essential frontline services can continue during the coronavirus pandemic.

It is vitally important that parents follow [Government advice](#) and keep their children at home where possible to help contain the spread of Covid-19. If your child cannot stay at home, then your childcare will be prioritised.

We have only a limited number of spaces at our hubs, and we are grateful to staff from our schools and the education department for providing this service.

Continued misuse of the childcare hubs could result in places being withdrawn; this is something that we do not want to do, however, we may have no choice if the situation continues.

Parents should expect to be questioned by reception staff at the hubs in order to discourage this behaviour. It may also be necessary to introduce other measures, for example, providing proof of key worker status, to prevent some parents taking advantage.

We would like to thank you for your co-operation on this so that we can continue to provide this vital service for you.

Dylai rhieni ddisgwyl cael eu holi gan staff y dderbynfa yn y canolfannau er mwyn annog pobl i beidio â gwneud hyn. Hefyd efallai y bydd angen cyflwyno mesurau eraill, er enghraifft, darparu prawf o statws gweithiwr allweddol, i atal rhai rhieni rhag manteisio ar hyn.
